GENERAL REGULATION PARKING AREA



- **1.** By entering the parking area with a vehicle, the driver and any other vehicle user (including a passenger), undertakes to comply with the provisions of this Regulation, which specifies the rules for using the parking area.
- 2. Parking is only allowed for vehicles up to 35 tons and without trailer.
- **3.** The users who are owners of a Subscription, shall not have to park in a predetermined or reserved space.
- 4. The user shall to park only in designated spaces and use caution when moving.
- **5.** The user shall park in such a way that it does not cause or is not likely to cause danger, obstruction or undue inconvenience to other users.

If the users fails to comply with the above-mentioned obligation, AMTAB shall be entitled to tow the vehicle away, at the expense of the user or also charge an additional fee according to the applicable Price List.

- **6.** Users shall be liable for any damage caused on the parking area premises, employees or third parties.
- **7.** AMTAB, pursuant to the article 7 (F) of the Rules of the The Highway Code shall not be liable:

a) for any damages arising out of the vehicle inside the parking area;

- b) in case of fire, theft, attempted theft or damage of the vehicle (including fittings and accessories)
- **8.** AMTAB shall be liable for damage caused by the automation system and /or by its Staff, but it shall not be liable for damage not reported to personnel before the vehicle leaves the parking area.
- **9.** Payment of the amount due for occupying a parking space as a Short-term User shall be made at the AM-TAB's cashier booths before removing the vehicle from the occupied space; once the User has paid the amount due, the employee shall provide him/her with the receipt required to leave the Car Park. Parking fees are not transferable.
- **10.**In case of loss o theft of the parking fee, the user shall pay the amount established by the Regulation, before withdrawing the car.
- **11.** If the user leave the vehicle besides the normal operating hours, it may be withdrawn at the subsequent re-opening, against payment of a fee.
- **12.** Each User is exclusively liable for any damage deriving from the loss, theft, or illegal use of the parking subcription. In case of loss or theft of it, the user shall immediately send to AMTAB a self- declaration pursuant to Art. 46 and 47 D.P.R. No. 445/2000, and declares to be aware of the penal sanctions in which would incur in case of false declarations.
- **13.** The users without parking subscription, can occupy a parking space for a maximum time of 15 days.
- **14.** Inside the parking area, the rules of The Highway Code are in force and The Users must drive no faster than walking pace, and in any case no faster than the indicated limits.
- **15.** In any case , inside the parking area, it is forbidden:
 - a) use open fire;
 - b) unload and store flammable, explosive or otherwise hazardous materials;
 - c) perform any type of vehicle repair work, clean the vehicle, release water, oil or any other substance inside the parking area;
 - d) leave a vehicle with the engine running;
 - e) park vehicles with substances which leak from it;
 - f) park the vehicle outside the marked parking space;
 - g) get in and out with vehicles beyond the 35 tons;
